Executive Summary

Envision Chaffee County is a county-wide community effort to help maintain our natural beauty, special sense of community and rural landscapes as we grow and prosper. As part of identifying what the community values, the Envision Core Team conducted a survey designed to gather input from a representative sample of the County's population. Community engagement in the Envision survey was excellent, with 1,203 total respondents – more than a quarter of whom asked to stay involved in the project.

The demographic summary of survey participants shows a strongly representative sampling of Chaffee County citizens. Coverage by zip code area, age bracket and work force participation is highly representative of County composition. Coverage of all income ranges is also high, but with somewhat of an under-representation of lower incomes and over-representation of higher income ranges. This potential bias was addressed by testing results for each survey question by income range and reporting any significant differences. A broad range of different lengths of county residency was also sampled, even though no county-wide data were available for comparison.

In summary, the Envision community survey is representative; it provides very clear and quantitative information about what the county's residents value most and what concerns them as they consider the County's growth.

At the highest level, the survey respondents envision a future where citizens and county/town governments collaborate to create a future Chaffee County that has maintained or enhanced:

- natural beauty;
- affordability (especially in housing);
- friendly small-town culture;
- rural landscapes and working ranches;
- exceptional outdoor recreation experiences;
- healthy, fire-resistant public lands; and
- a prospering economy.

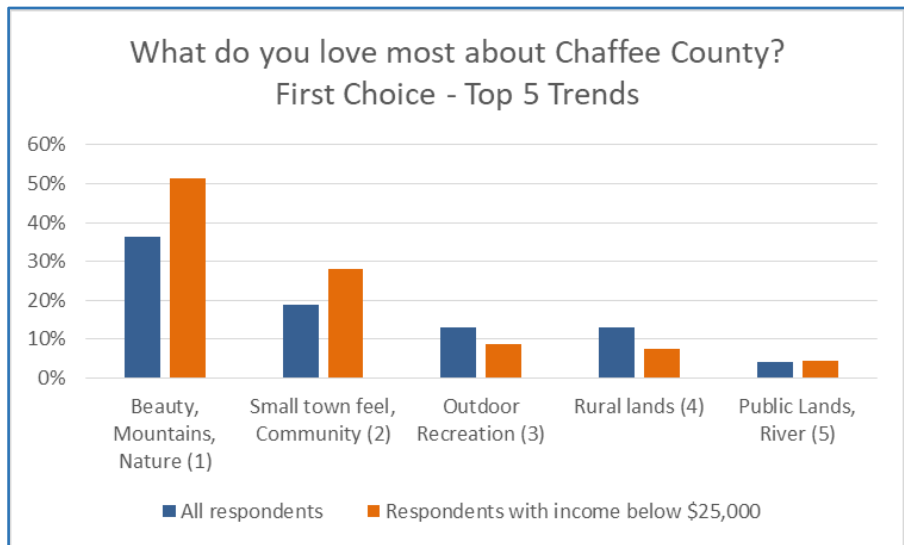
I. What do Chaffee County residents value most?

When asked “what do you love most about Chaffee County?” (Question #1), respondents were consistent in their answers. Of 1,190 responses, more than half used the following words (in order of frequency):

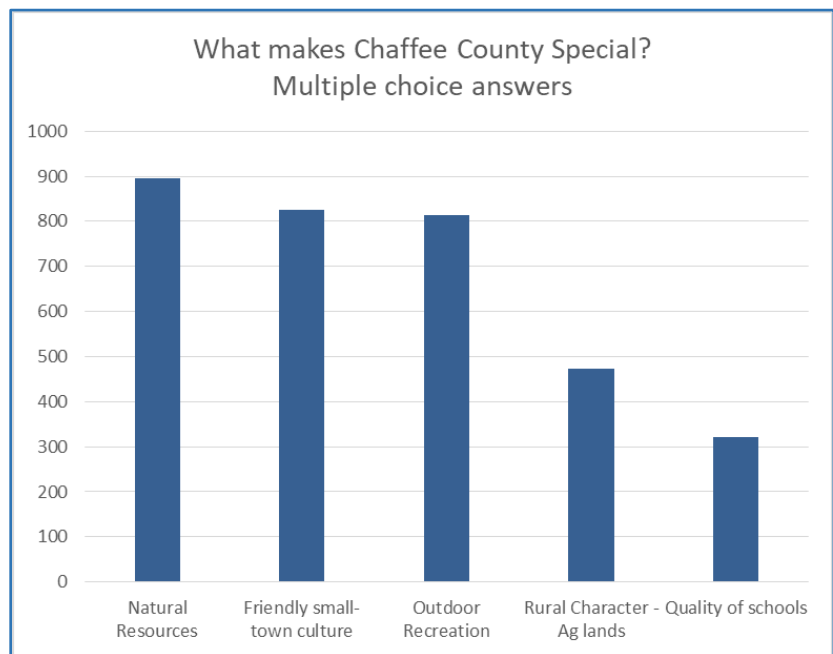
Mountains Beauty Outdoors Community Natural Small Town

When responses were sorted into categories, five themes emerged, common among all ages and income ranges:

1. Natural beauty
2. Community and small town feel
3. Outdoor recreation
4. Rural agricultural landscapes
5. Public lands and the river



The same top themes are verified by multiple-choice Question #3, asking “what makes Chaffee County special?” Here, 67% of responses identified natural resources, friendly small-town culture, outdoor recreation and rural character/agricultural lands as the most important assets.

Additional survey questions provided a deeper perspective on the five things citizens value most (with rank):

A. Natural Beauty (1st), Outdoor Recreation (3rd) and Public Lands and the River (5th)

These physical assets are closely related, and form the core of Chaffee County’s identity.

When asked “what are your top priorities for management of public lands and the river?” respondents indicated a priority toward protection versus toward increased access to outdoor recreation (Question #4).

Ensuring public lands are not sold or transferred	24%
Managing the environmental impacts of recreation	21%
Protecting water quality and water supply	20%
Protecting wildlife habitat	15%
Maintaining the quality of outdoor recreation	13%
Increasing access to outdoor recreation	7%

B. Sense of Community (2nd)

Sense of community and small town feel is the second-most valued attribute in Chaffee County (after natural beauty). This attribute was described by words including:

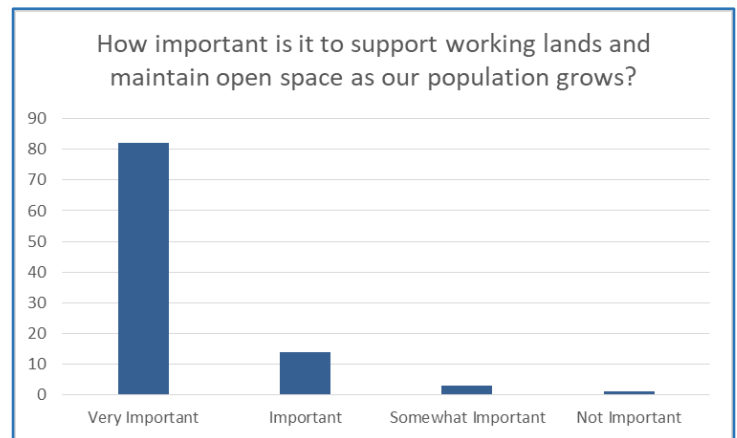
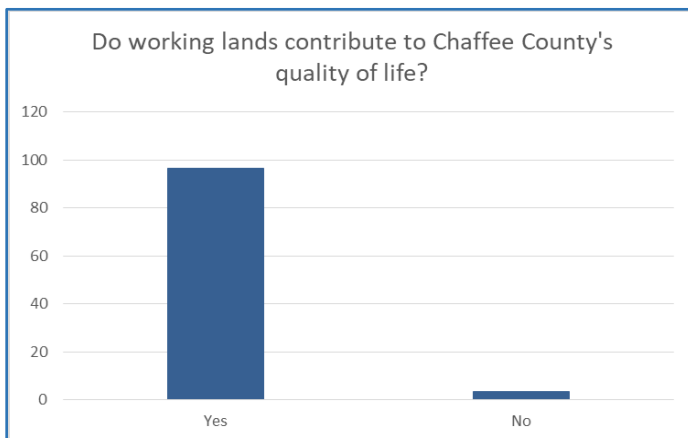
Caring Friendly Welcoming Involved Slow-paced Not crowded

Likewise, loss of this special sense of community is identified as a top concern in questions #2 and #9.

C. Rural landscapes and open agricultural lands (4th)

Rural landscapes and working agricultural lands are the 4th most-loved asset by respondents of all income and age classes (Question #1). This theme is further supported by responses to Questions #6 and #8:

**97% of respondents believe working lands contribute to Chaffee County’s quality of life
96% indicate it is important or very important to support working lands and to maintain open space as the County grows**

Participants also indicated that they believe working lands contribute to Chaffee County’s quality of life not only by supporting open space and views, but also by representing the community and culture, keeping water rights local, providing wildlife habitat, and providing local foods.

II. What are Chaffee County citizens’ most pressing concerns?

Looking beyond what the community values about Chaffee County, the survey explored what residents believe are the most pressing concerns relative to the area’s projected growth in population and tourism (Questions #2 and #9), and related to changes in forest health (Question #5).

In response to “what are the top three most pressing challenges for Chaffee County, when you consider coming growth in population and tourism?” top words (in order of frequency) include:

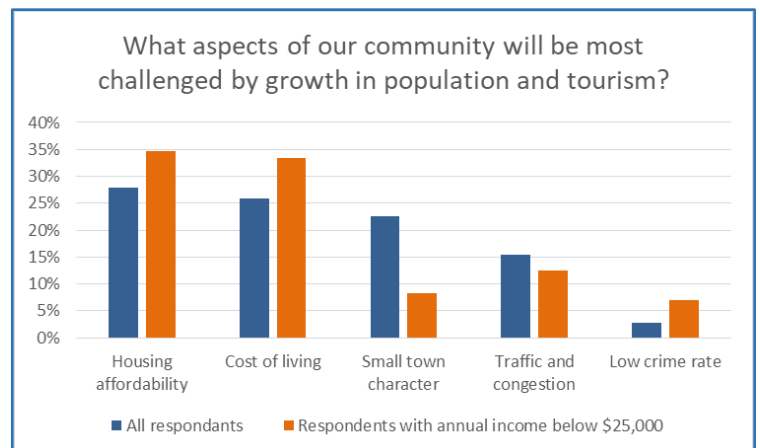
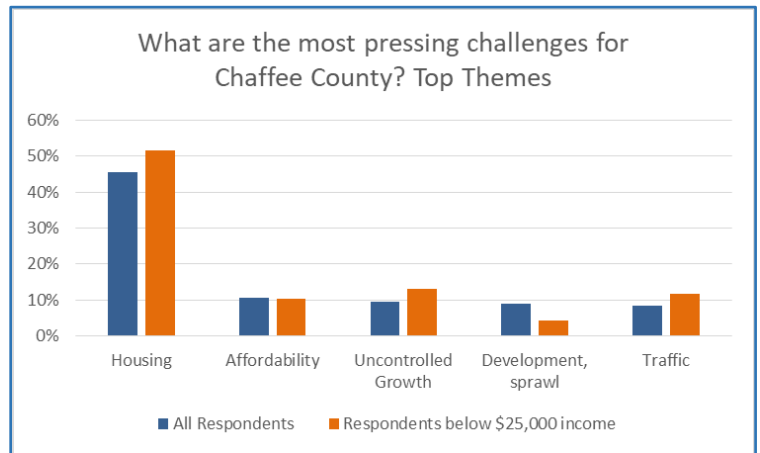
Housing (with 40% of responses)
 Traffic Growth Cost Jobs Land Water

When the responses were sorted into categories, again five themes emerged that are common across age and income ranges:

1. Housing (for employees, seniors, families)
2. Overall affordability and rising costs
3. Growth (too much, too fast, unplanned)
4. Development of rural areas
5. Traffic

A shortage of non-seasonal jobs with higher wages was a sixth theme, for 6% of respondents.

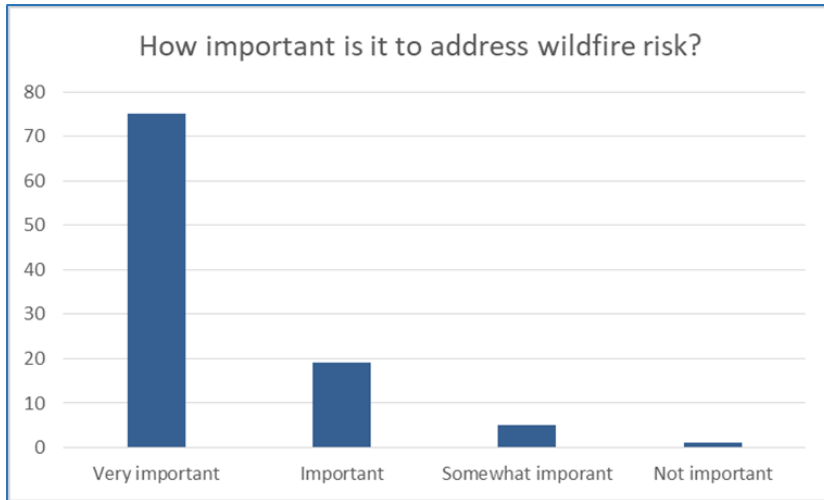
Concerns about housing affordability, rising cost of living and traffic are reinforced by multiple choice responses in Question #9. Responses here also identify loss of small town character as a top 5 concern, especially for people with annual household incomes greater than \$25,000.

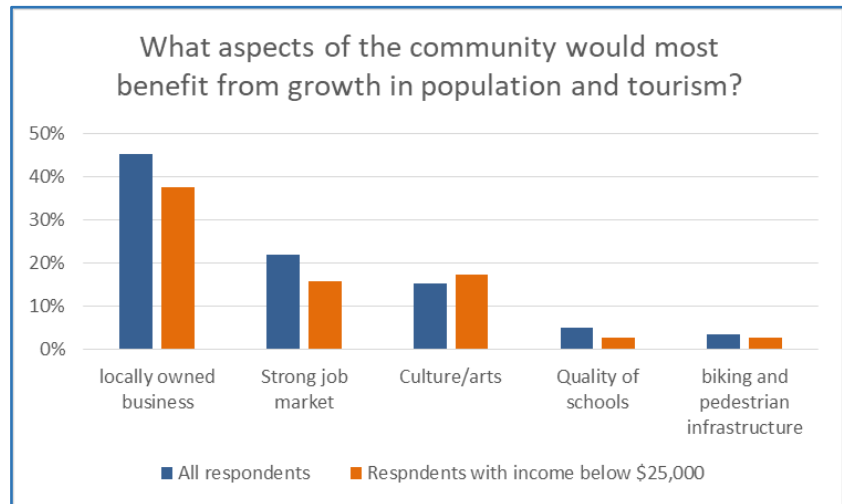
With growth, the potential impact of wildfire increases as development increases, especially at our public lands interfaces. At the same time, rapidly advancing beetle infestation in our forest is increasing the risks posed by wildfire. When asked “how important do you think it is for our community to discuss and address wildfire risk?” (Question #5):



95% of 1,131 respondents indicated that managing wildfire risk is “important” to “very important.”

III. Growth-related opportunities

The final survey question asked what aspects of the community could most benefit from growth. Top responses were locally owned businesses, a strong job market and increasing support for the arts community, schools and biking/pedestrian infrastructure.

Full Survey Report Introduction

Envision Chaffee County is a county-wide, community-based initiative to identify what residents value the most in their communities and to create a plan to maintain those aspects and features as the county grows and prospers. Whether it is healthy public lands, recreational opportunities, quality schools, rural landscapes or a welcoming small-town attitude, Chaffee County residents are being given the opportunity to share their thoughts – as well as concerns about the future – through the Envision initiative.

Why now? Chaffee County’s population is projected to increase 31% by 2030 and 52% by 2050 (State Demography Office). Anticipating such a surge in population and associated changes to the community, the Envision Chaffee County project was initiated in early 2017 by a group of citizens. In September, 2017, the Chaffee County Commissioners unanimously agreed to convene the initiative, with support from the Central Colorado Conservancy. The three-phase Envision project officially began in the summer of 2017 and will conclude in May 2018 with an implementation plan.



Funding for the program was provided for Phase I by the LOR Foundation (\$100,000). This initial funding has been supplemented by: the Colorado Department of Local Affairs (\$25,000), and Chaffee County (\$5,000). Local community members are also providing nearly \$70,000 in in-kind support.

Phase I is facilitating a community conversation about impending challenges stemming from growth through town meetings, a survey and one-on-one interviews. The aims are to create a shared vision for the future, and to encourage citizens to think strategically about how to protect and enhance Chaffee County’s best assets as the community evolves. More than 1,200 residents (1,203 total) took the Envision survey, and those results are summarized in this report. They will also play a key role in informing Phases II and III of the project.

Survey Overview

Phase I of **Envision Chaffee County** facilitated a conversation about what residents value in their communities, and what the impending challenges are from the projected population growth. Input was gathered through the following tools and activities:

- Town Hall Meetings
- Community Survey
- One-on-One Interviews

The Project Core Team designed the survey to learn more about residents' priorities and attitudes about the things that they believe are Chaffee County's best attributes. The survey took approximately 10 minutes for participants to complete, and was administered online at www.envisionchaffeecounty.org from September 16th through October 31, 2017. A total of 1,203 people took the survey, representing approximately 6% of Chaffee County's population.

All survey responses were anonymous and confidential, but respondents had the option of providing their name and contact information if they wanted to be kept informed and potentially continue to participate in the project as it progressed. A total of 298 respondents opted to provide their contact information – nearly one-quarter of all survey participants.

The Envision Project Team promoted the survey to the community via:

- Business cards (900 printed) with the survey link and purpose distributed at local businesses throughout Salida, Buena Vista and Poncha Springs
- Envision Chaffee County Facebook page
- Partner websites and member e-mail communications
- Local newspapers: *The Mountain Mail* and *The Chaffee County Times*
- Local radio public service announcements

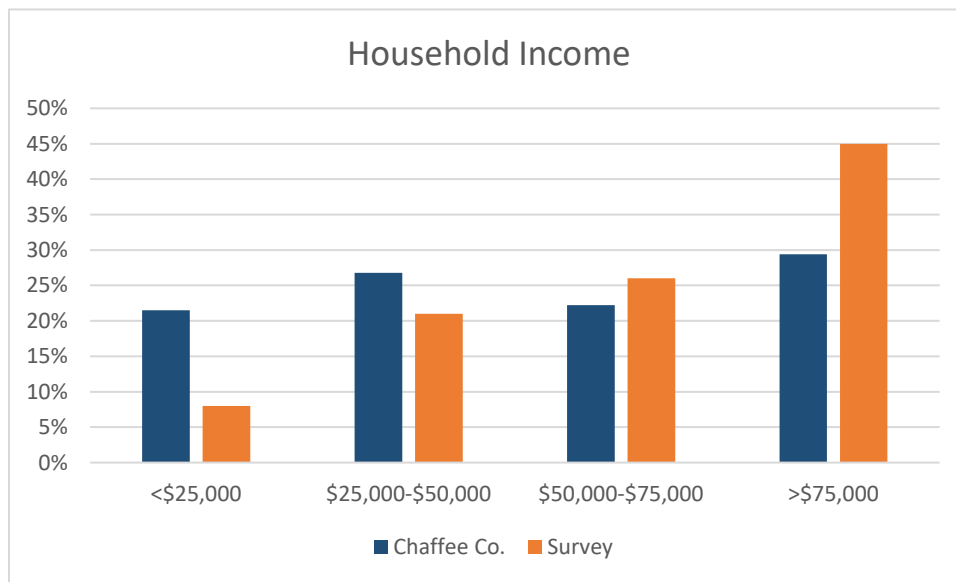

Demographic Profiles: Chaffee County Residents vs. Envision Chaffee County Survey Respondents

The Envision Chaffee County survey asked respondents to provide key demographic information to help the Project Core Team and facilitators understand how well the survey represents the overall community. This information was not a requirement for the survey to be counted.

Every effort was made by the Team to engage a broad cross-section of residents by asking a wide range of local organizations and agency partners throughout the County to promote the survey to their constituencies, by distributing 900 cards with the survey link information, and by providing paper copies of the survey as needed. However, there were notably fewer respondents in the <\$25,000 category for household income than other categories; this was taken into account throughout the analysis of the survey data. Chaffee County data was provided by the State Demographer's office, and it is from the most recent (2010) Census.

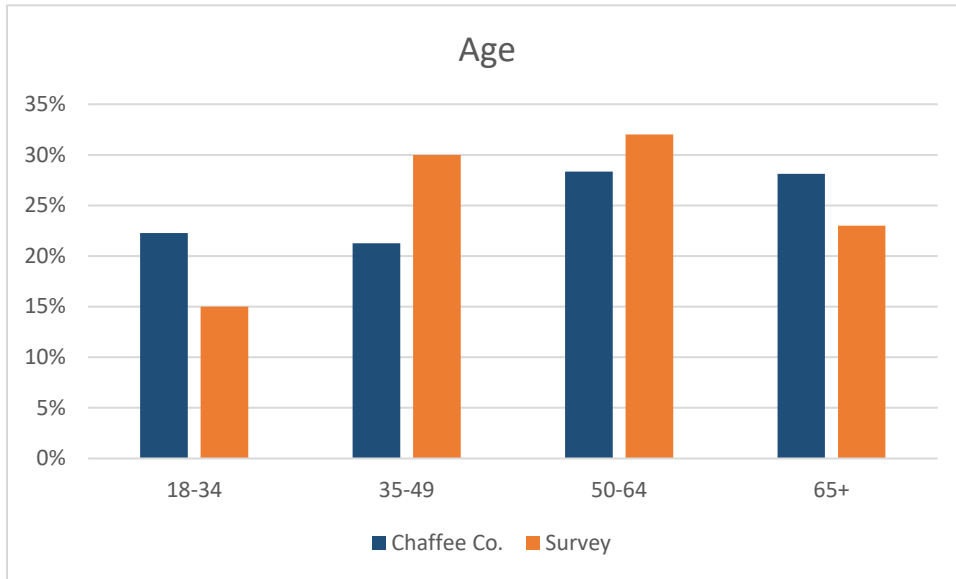
What is your household income? (1,042 responses)



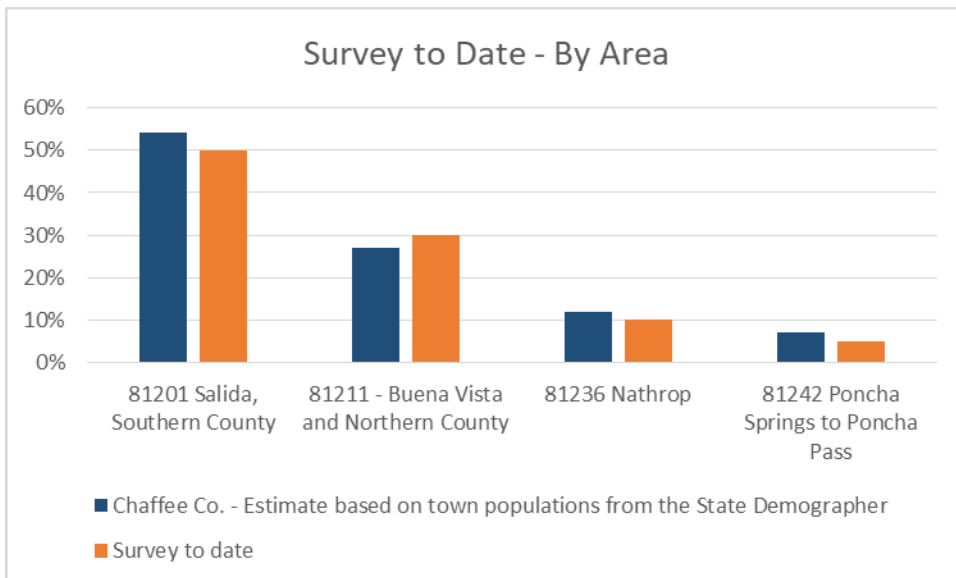

What is your zip code? (1,087 responses)



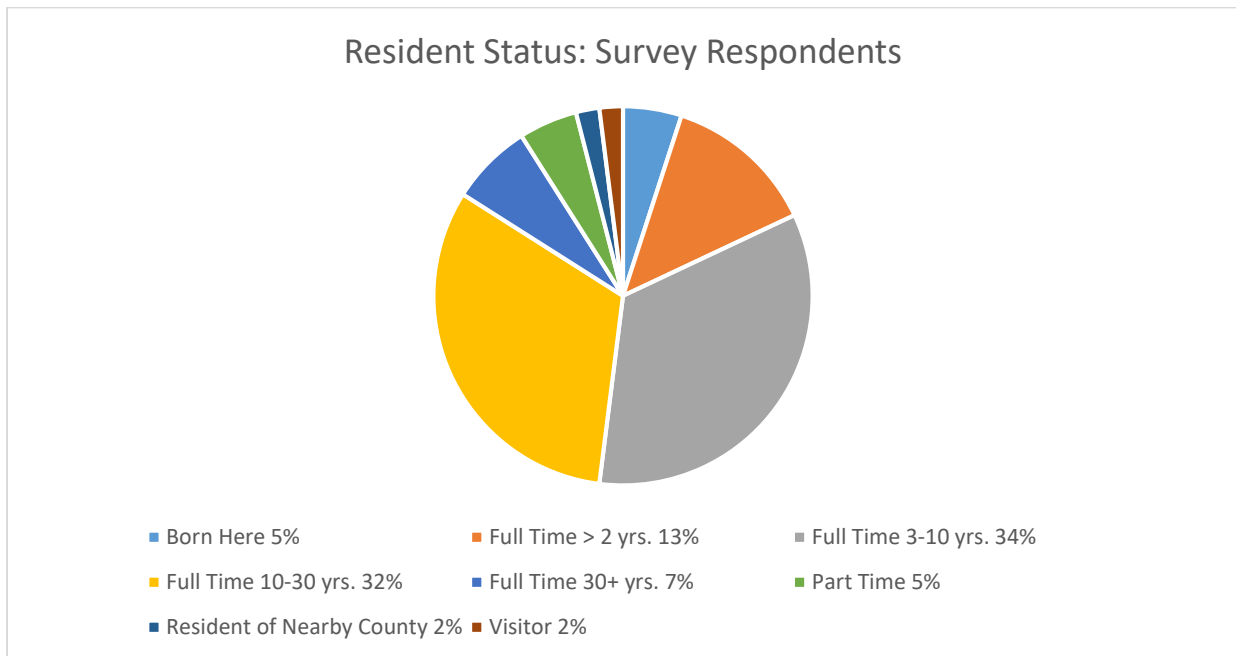

In addition, the survey asked participants to provide information on how long they have lived in Chaffee County and their employment status. State demographic data are not available for comparison of residency length, but a broad spectrum is represented. Respondent employment status is highly representative of the actual population based on census data.

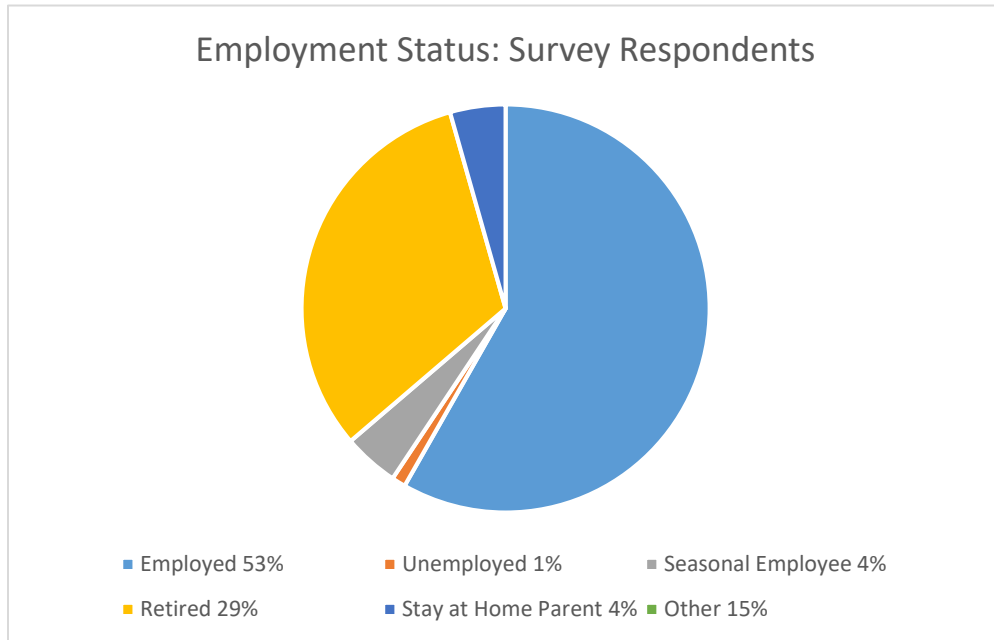
How long have you lived in Chaffee County? (1,093 responses)



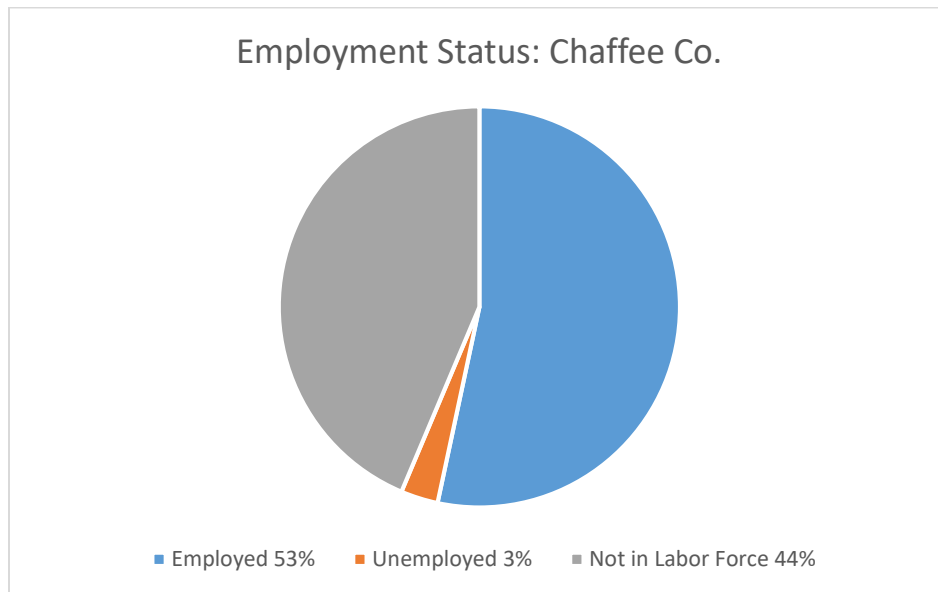

Note: Most Chaffee residents are employed (53.27%), though a sizable portion of the County is defined as "not in labor force" (43.58%). As defined by the Census Bureau, this refers to "All persons 16 years old and over who are not classified as members of the labor force. This category consists mainly of students, housewives, retired workers, seasonal workers interviewed in an off season who were not looking for work, institutionalized persons, and persons doing only incidental unpaid family work (less than 15 hours during the reference week)."

The word cloud compiled from all responses illustrates the items that were listed most frequently (larger size):



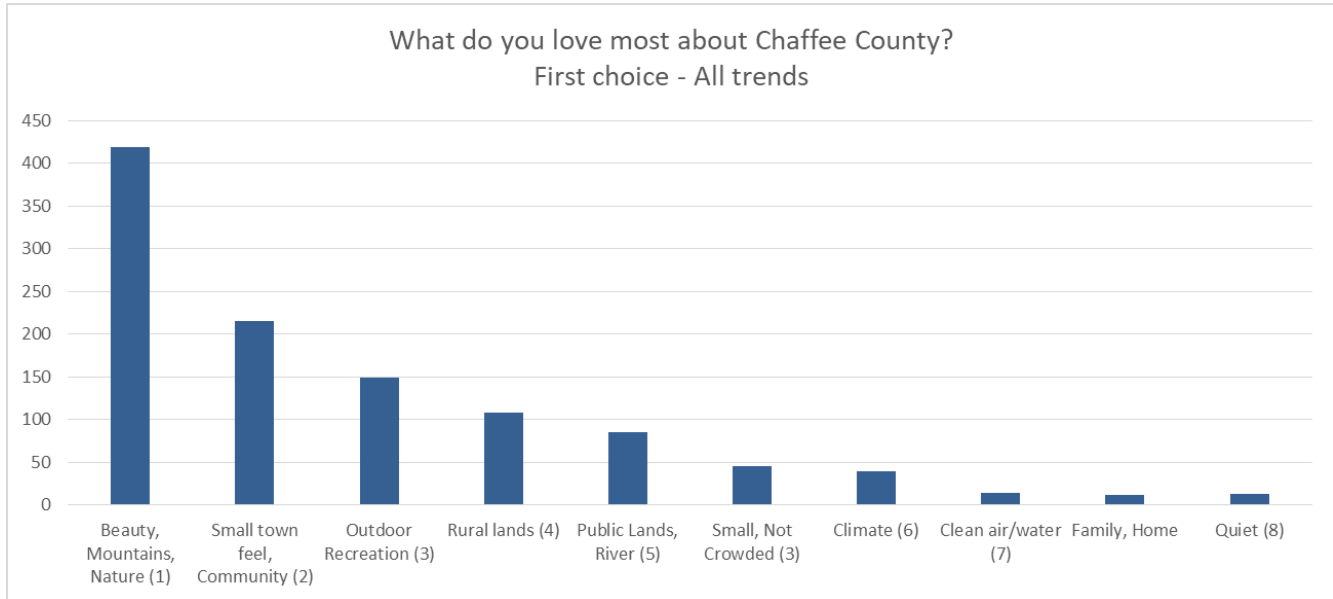
The individual words and phrases were compiled into trends using the categories below:

1. Beautiful scenery, scenery, mountains, beauty, blue sky, landscapes, vistas, views, natural beauty, nature, access to nature, natural resources, outdoors
2. Community, caring community, volunteer community, neighbors, tight knit community, people, authentic people, small town feel, real community, friendly, welcoming
3. Recreation, access to recreation, outdoor activities, 14rs, skiing, trails, adventure, biking, fishing, hiking, hunting
4. rural lands, open space, open land, agriculture, rural, hay fields
5. Public lands, forest, wilderness
6. Climate, weather, sunshine
7. Clean air, clean water, lack of pollution, no smog
8. Quiet, solitude, peaceful

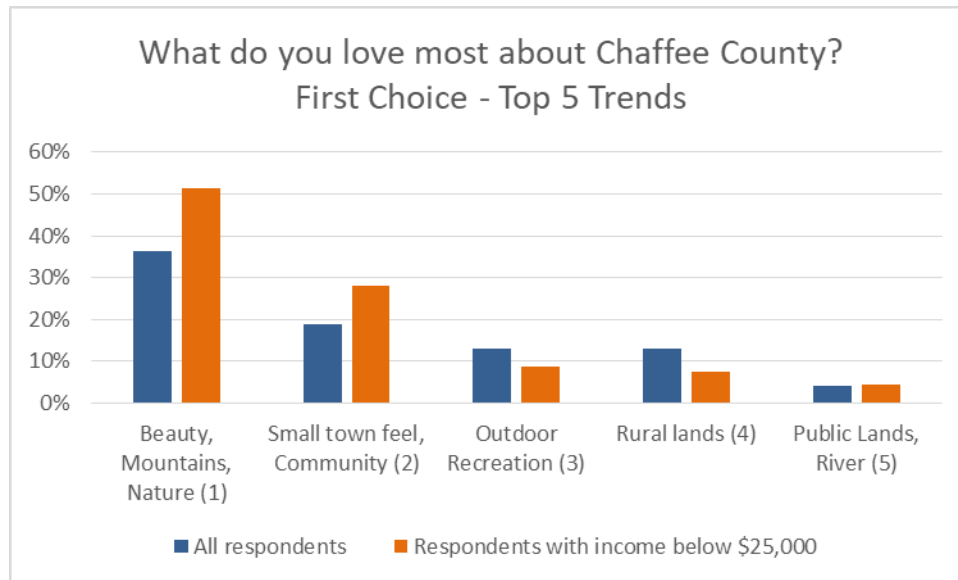

This word cloud compiled from all responses illustrates the items that were listed most frequently (larger size):



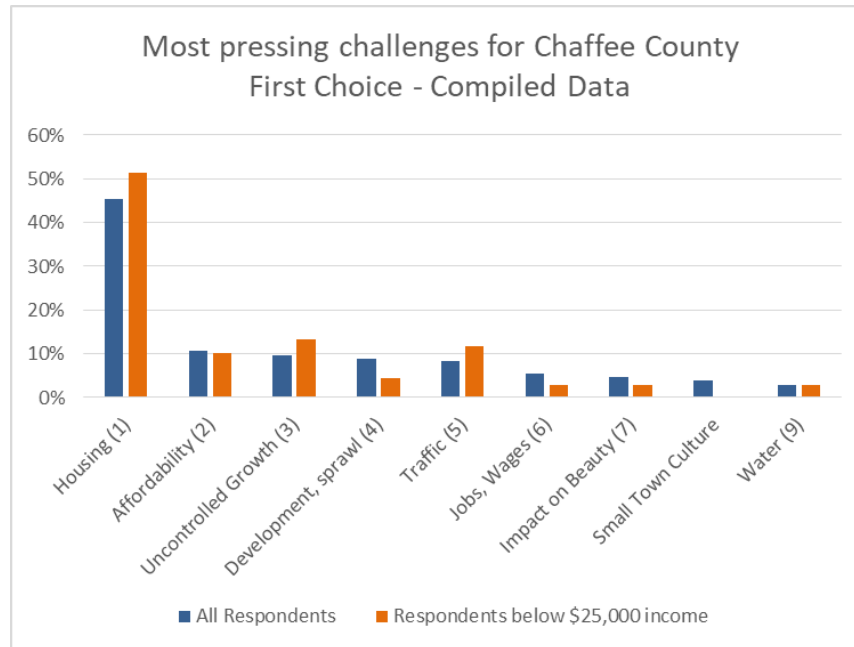
The individual words and phrases were compiled into trends using the categories below:

9. Water, loss of water rights, in-sufficient water

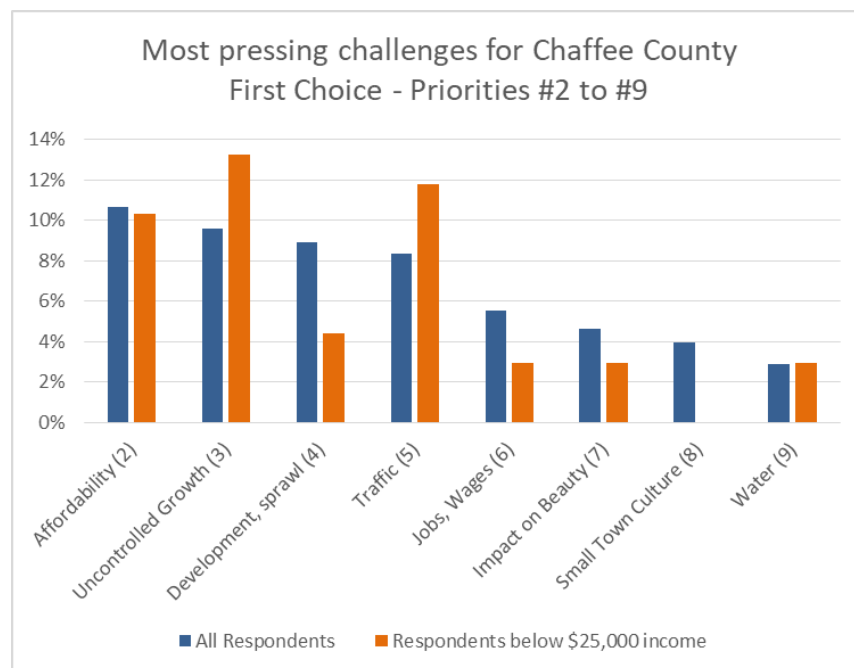

Graph illustration of trends for respondents with household income <\$25,000. Note that four of the top five trends are the same as for the total survey respondents:

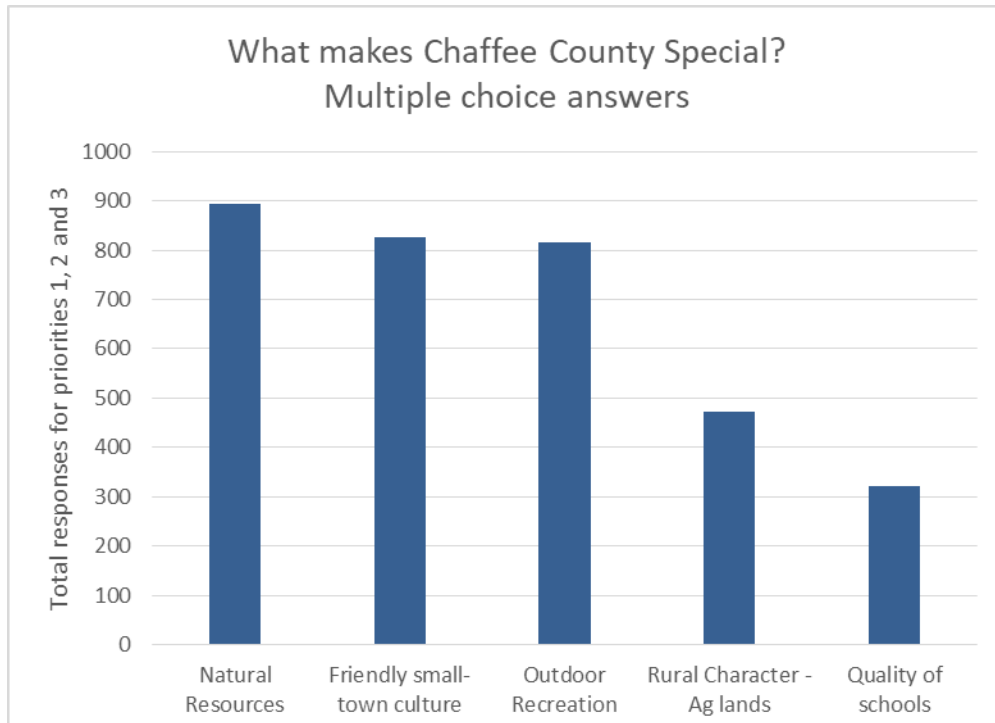

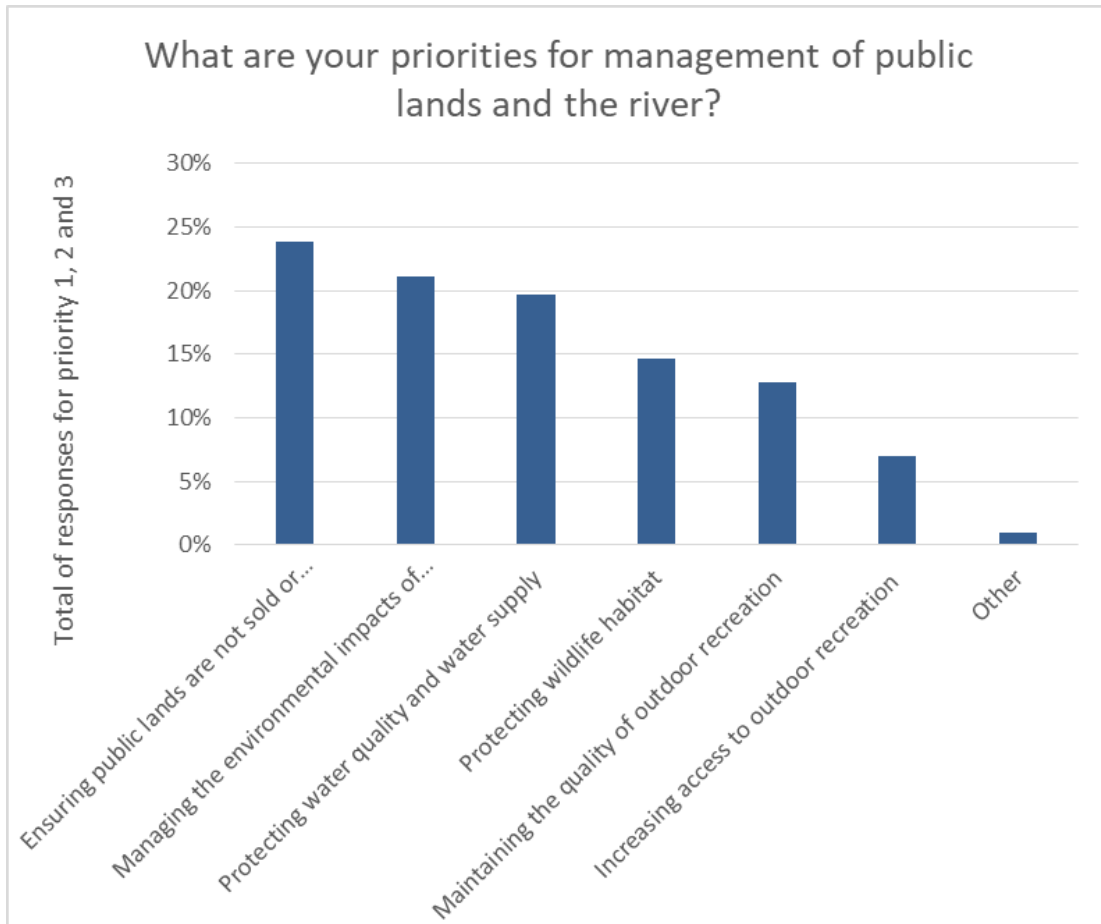

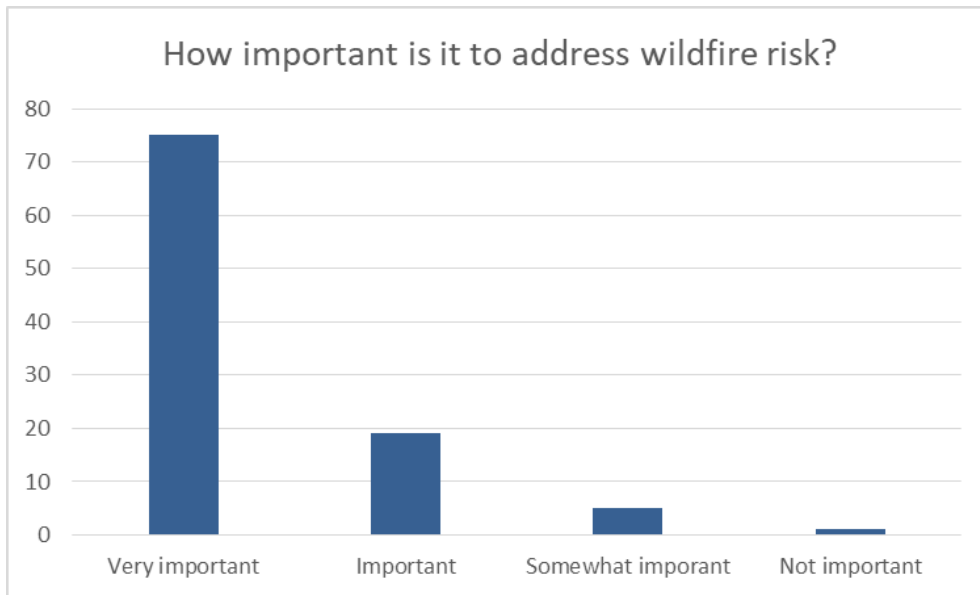

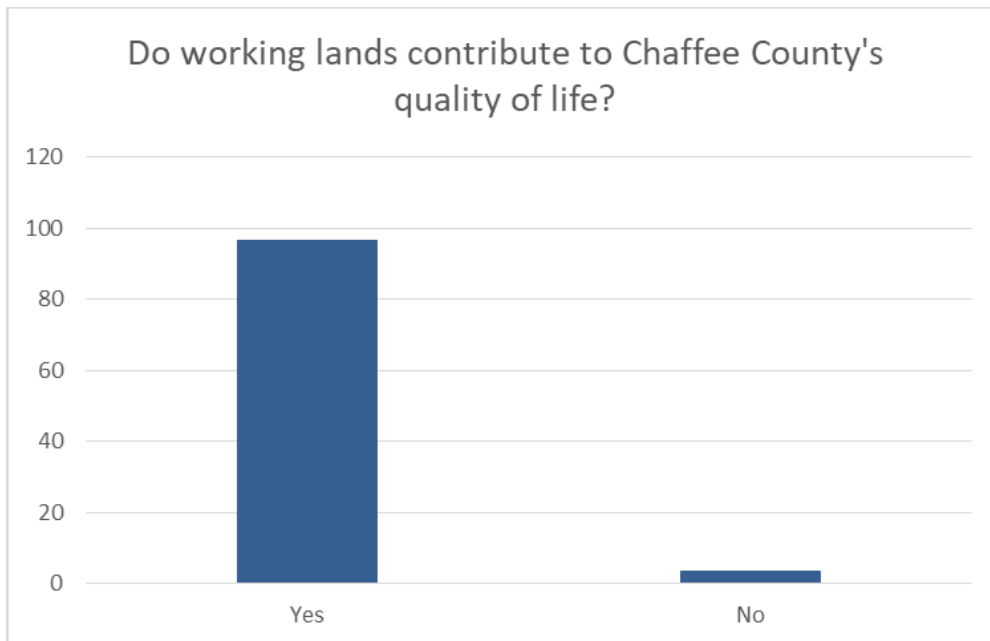

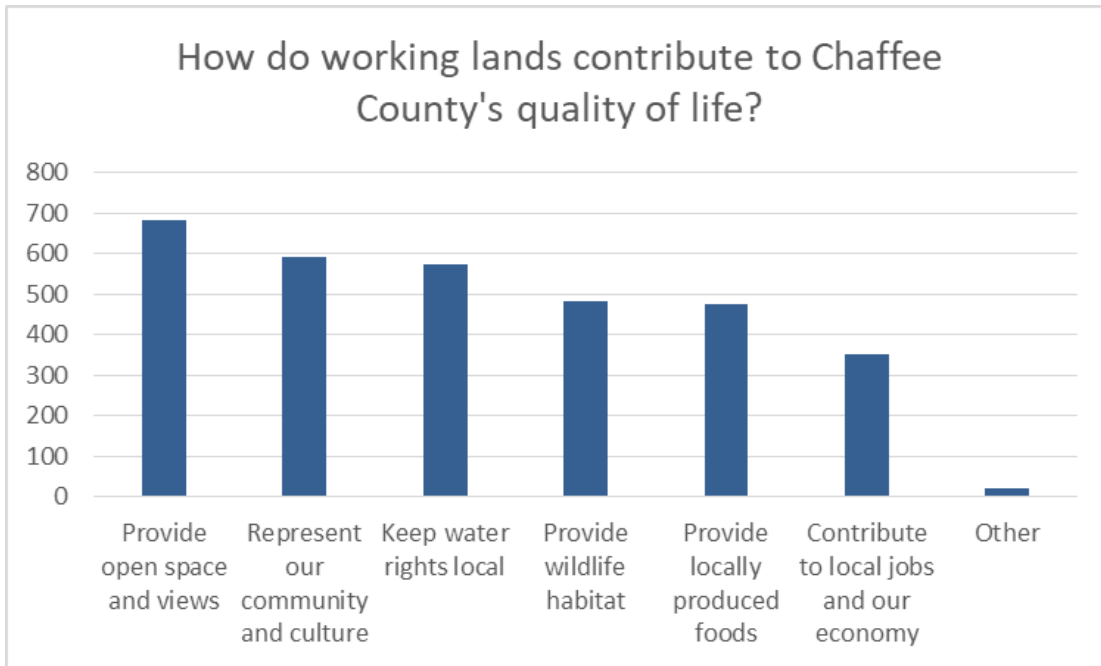

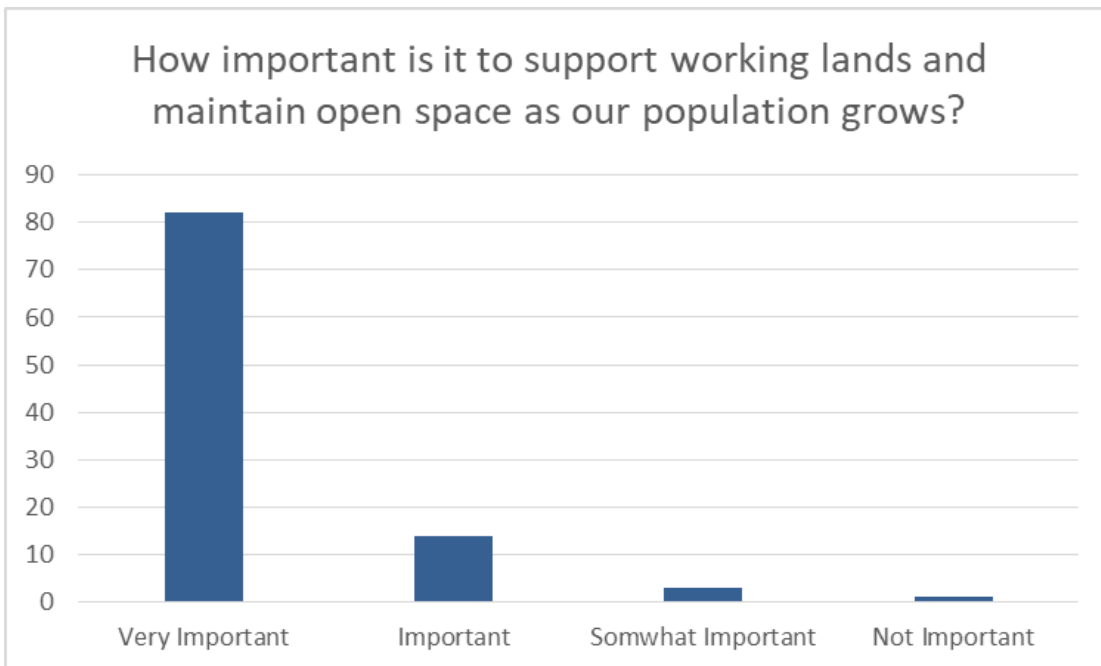

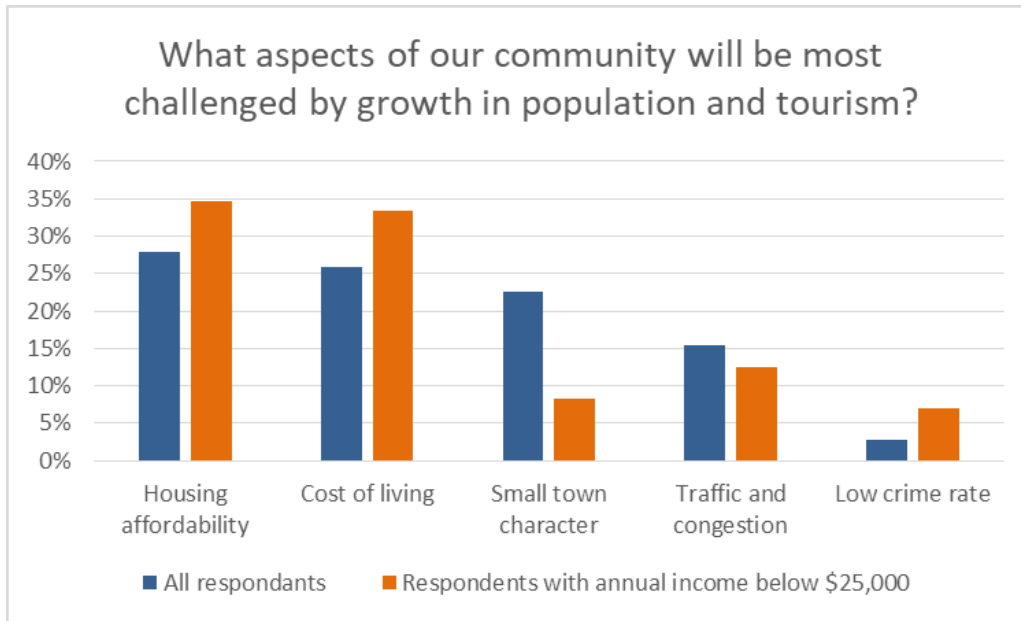
Question #8: How important do you think it is to support existing working lands and maintain open spaces as our population grows? (1,121 responses)



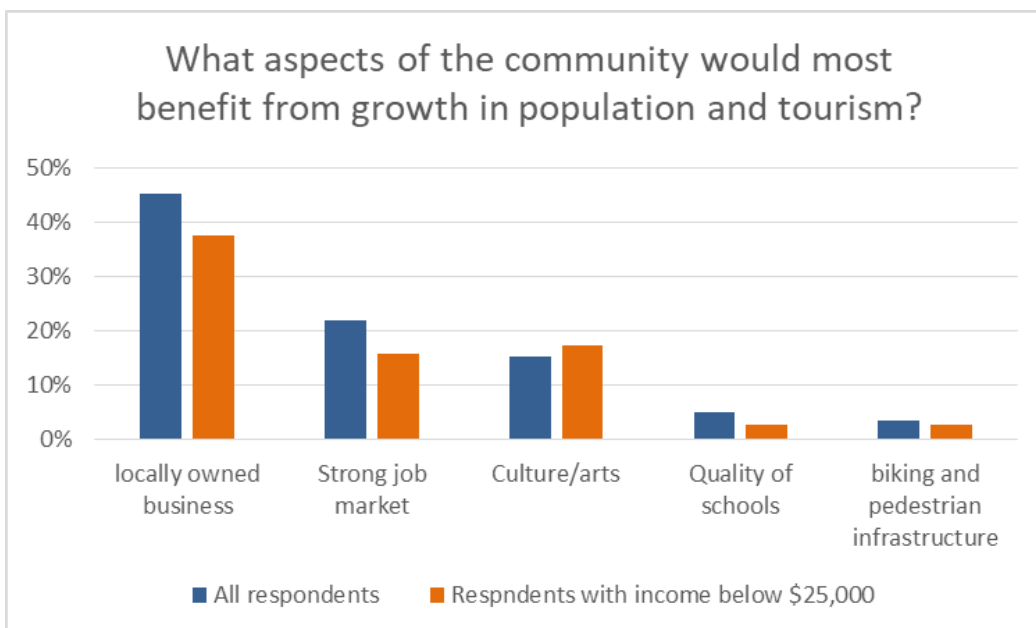
